The Direct Debit Guarantee

This Guarantee is offered by all Banks and Building Societies that take part in the Direct Debit Scheme. The efficiency and security of the Scheme is monitored and protected by your own Bank or Building Society. If the amounts to be paid or the payment dates change, The Conservative Party will notify you at least 10 working days in advance of your account being debited, or as otherwise agreed. If an error is made by The Conservative Party or your Bank or Building Society, you are guaranteed a full and immediate refund from your branch of the amount paid. You can cancel a Direct Debit at any time by writing to your Bank or Building Society. Please also send a copy of your letter to The Conservative Party, 30 Millbank, London, SW1P 4DP.



Political Party Elections and Referendums Act 2000 Under the Political Party Elections and Referendums Act 2000 (PPERA) you must be on the electoral register in the UK excluding the Channel Islands and the Isle of Man in order to make a donation of more than £500. If you donate more than £7,500 to the Party, we are obliged under the PERA to report such a donation to the Electoral Commission, who will publish the fact that you have made a donation over £7,500.
